NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2025.
(2) They shall come into force with immediate effect.

2. Amendment of rule 62.- In rule 62 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, the existing sub-rule (iv) shall be deleted.

3. Amendment of rule 67.- In rule 67 of the said rules, the existing EXPLANATION (1) shall be substituted by the following, namely:-

"(1) A son/daughter shall become ineligible for family pension from the date he/she gets married or on earning a monthly income exceeding rupees 12,500/- per month. He/she shall be required to produce six monthly a certificate regarding marital status and an annual certificate regarding monthly income:

Provided that in case of son/daughter suffering from a mental or physical disability,-

- (i) his/her marital status shall not affect the eligibility for family pension; and
- (ii) he/she shall not be ineligible, if his/her monthly income does not exceed the total amount of rupees 8,850/- and dearness relief payable thereon at the prevailing rate."
